#### 1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

#### **Response:**

Sane Guruji Shikshan Prasarak Mandal's Nashik Road Arts and Commerce College, Baragaon Pimpri is affiliated to Savitribai Phule Pune University, Pune and follows the curricula prescribed by the affiliated University. The College ensures effective curriculum delivery through a well planned and documented process. The IQAC prepares the academic calendar of the college and the concerned departments prepare their departmental time table before the commencement of every academic year. The faculty members are briefed on the academic activities of the college on the first meeting of the commencement of every academic year. Heads of the department arrange departmental meetings to distribute and assign the workload. Considering the workload and planning held in the departmental meetings, the syllabus is disseminated as per classes and courses for effective teaching. Faculty members prepare a semester-wise teaching plan at the beginning of every term and semester. Every faculty member is provided with an academic diary containing time-table, workload, Annual and Semester teaching plan, actual teaching units, daily teaching plan, and administrative committee responsibilities. The academic diary is monitored by the concerned Head of Departments and the Principal of the college. The time-table committee prepares a general time-table and the head of concerned departments prepare departmental time-table. The teacher conducts classes according to the timetable. IQAC and departmental meetings are held periodically to review the completed syllabus. For the effective transmission and delivery of curricula, departments integrate classroom teaching with various ICT tools, field projects, student seminars, tutorials, sessions of solving the question papers, poster presentations, field surveys, etc. For the up-gradation of subject-related knowledge, the college organizes seminars and workshops. This activity provides a platform for teaching, non-teaching, and the students to participate and interact with the experts in various fields and enrich and update their subject knowledge. For effective curriculum delivery, teachers use participative, problem solving and student-centric learning methods. Faculties effectively use ICT tools for delivering the subject knowledge. The college organizes guest lectures, expert lectures of eminent academicians for the effective curriculum delivery. College also provides special guidance to the slow and advanced learners under the Special Guidance Scheme of Savitribai Phule Pune University, remedial coaching. college has a mentoring system for academic-related issues. The central library of the college provides an e-content facility. Teachers provide study material to the students through , WhatsApp group and an update college website. IQAC recently conducted the Academic and Administrative Audit by the external agency for further improvement in academic and administrative activities. At the end of the academic year, IQAC collects feedback on curricula from the students, teachers, parents, alumni and employers. It is analyzed by the proper mechanism constituted by the college and the report is communicated to the concerned departments and the university.

The college has initiated continuous and comprehensive internal evaluation under the norms and guidelines of Savitribai Phule Pune University, Pune. The central examination committee of Sane Guruji Shikshan Prasarak Mandal Nasik Road Art's And Commerce College Baragaon Pimpri prepares the examination schedule and it is communicated to the college. The college communicates this schedule to students on the examination notice board, besides every teacher make announcements in the classrooms. The benchmark of the evaluation includes attendance, tutorials, practicals, field projects, research projects, assignments/seminars/ oral presentations, and the score secured in the internal tests. All the first-year programs have a Choice Based Credit System (CBCS) from 2019 and internal evaluation is undertaken as per the affiliated University rules. For CBCS pattern of 2019 the concern Subject teachers prepare internal question papers by keeping all the confidentiality. The college exam committee looks after for semester and internal examination. It prepares of a comprehensive schedule which is carried out in said time.

All the subject question papers are set by the central examination committee of Sane Guruji Shikshan Prasarak Mandal Nasik Road Art's And Commerce College Baragaon Pimpri. The question papers for the internal examination are prepared in a uniform pattern and as per the guidelines of the University. The exam is conducted on a common schedule and supervised by the junior supervisors. The syllabus for the internal examination is communicated to the students in advance by the subject teacher concerned. The answer sheets are shown to students after evaluation for their information which provides transparency and accountability in the evaluation process Student's grievances are taken care of and are redressed in a timely manner. The marks of internal examination are displayed on notice board and college website and are also communicated to the students in their respective classes. Online internal marks are submitted to the university through the teacher's login accounts on the university internal examination portal. All marks of the Internal and External examination of all students have been entered into the excel sheet. 1. Title of the Practice

TARUPREET PRAKALPA

- 2. Objectives of the Practice
- 1) Tarupreet project was undertaken with the main objective of greening the barren land in Sinnar taluka.
- 2) Since the amount of rain in Sinnar taluka is very low, from that point of view this project can be beneficial for it.
- 3. The Context

Uncertain changes in the environment, variability of rainfall, all these aspects show human encroachment on the environment. This problem faced by the whole world needs to be considered on a personal level. Recognizing the need of the hour, we have undertaken a project to make the barren area green, to make a green revolution. Sinnar taluka is a drought-prone part of Nasik district in the east. That's why we thought to make the area green and flourishing in the future by planting seeds on the barren land and that's how the project started.

#### 4. The Practice

What can we do to help nature sustain its existence, can we do something creative? Such a question arose in my mind. Basically, since I myself have a great love and interest in nature since childhood, this question did not allow me to sit still.

In March 2019, with the help of the students, we collected some seeds and went to the barren area before the onset of monsoon and planted the seeds. In the month of March, the students of the college were explained about the activity and given complete information. And the students really liked it. Their enthusiasm made me feel excited too. Since the month of March, I have received the seeds of mango, tamarind, wad, karanji, Custered apple, neem trees from the students. The students were divided into groups and distributed to each group and we found an area in Sinnar taluka where there is a great need for planting trees, growing greenery. After going to such a place, we took a look at the situation there and undertook a program to plant seeds of trees that can withstand low water, can withstand and cannot be eaten by animals. Seeds were sown on barren thorny and thorny trees so that the seeds would take root on rain water. We chose seeds that can survive on less water so that the seeds we plant will take root quickly and will soon be ready to restore their greenness to nature even if they receive less water. And we have been successfully implementing this activity since 2019 as planned. We have not taken any form of money from any organization or person. We have so far planted more than 13000 thousand seeds in Sinnar taluka.

5. Evidence of Success

Since March 2019, we have been making tireless efforts to plant seeds on the wasteland of Sinnar taluka. In the beginning, it took some effort to impress this activity on the minds of the students. But gradually students started participating with great enthusiasm. They also developed the attitude of serving nature.

6. Problems Encountered and Resources Required

For the past three years, the project started by Tarupreet for environmental conservation has become a teacher for us. Many new things came to our attention on this occasion. In the beginning, it was risky for us to go to the barren plains for seeding, because we also went for seeding in areas where tigers and leopards roamed. Still we started our work taking care and following the advice of locals. In the first year, we had to work a little harder to collect the seeds.

#### Title of best Practice

#### ORGAN DONATION PROGRAMME

- 2. Objectives of the Practice
- 1) The said activity has been started to create public awareness about human organ donation among people in rural areas.
- 2) In a country like India, many people are fighting death while waiting for an organ and for them this initiative can be of great benefit.
- 3) If the said activity is undertaken at the college level, it can have a positive effect.

#### 3. The Context

India is grappling with acute shortage of organs for transplantation. An estimated more than one million people suffer from end-stage organ failure, but relatively few receive transplants. At least 15 patients die every day waiting for organs. Also every ten minutes a new name is added to this waiting list. So obviously the demand for organs is much higher than the availability.

#### 4. The Practice

Mr. Subhash Kela, who earned his distinct reputation as an entrepreneur, with a firm determination to drive the welfare of humanity, personally started the important work of organ donation with our college in 2017. Ever since he involved the students of our college in the organ donation activity, his representatives and he himself came as a wife and explained to our students the need for organ donation, the importance of organ donation and the technical aspects of it through the said activity.

Human existence is fleeting and if we want to live even after death, we can give someone a direction to live by taking up the task of organ donation, devoting ourselves to it. We can turn someone's despair into happiness, we can become a smile on someone's lips. Vijay Kela created this feeling in the minds of our rural students. As a result of this, our students and faculty voluntarily became a part of the organ donation initiative. In the organ donation program conducted in the year 2017.

Ever since the big and important movement like organ donation started in our college, many positive changes have been seen. This project which started with the efforts of Shri Subhash Nandalal Kela got a very good response from the college.

#### **Environmental Conservation**

Arts and Commerce College Baragaon Pimpri run by Sane Guruji Shikshan Prasarak Mandal Nashik Road is a college in a rural and drought-prone area. Having closely experienced the lives of people affected by the unpredictable and erratic nature of rainfall, our college has taken a big step right from the beginning to conserve the changing environment. College of Arts and Commerce, Baragaon Pimpri and its surrounding area is a shallow and barren land, so the rainwater that falls here dries up quickly. Also, since the number of trees is less, there is not much scope for rain water to be blocked. Considering all these aspects, our college has started efforts to maintain the balance of the deteriorating environment by taking up environmental friendly activities and thinking about what special contribution we can make for this and are continuing even today Between 15th May 2018 and 21st May 2018, our college worked hard and carried out a big project for water conservation at Baragaon Pimpri. To conserve water in the village, works like digging trenches on the mountains and creating check dams in the river area were done. At this time Prof. Sandeep Kapadi, Prof. Kiran Sonawane conducted a different activity by guiding the college students properly. Which was very beneficial for the environment.

In December 2019, in Deshwandi village of Sinnar taluka, our students made another attempt to drain the rainwater by digging a trench on the top of the hill.

Our college has also worked with the water Foundation to help create an environment friendly environment. During the year 2017-2018, we have done water conservation and related work under Pani Foundation. We got a spontaneous response for this. Prof. This activity was implemented under the guidance of Sandeep Kapadi and Prof. Kiran Sonawane. Village people also got a good response to this activity. Environment friendly activities are continuously implemented by the students of our college. For this, the Swachh Bharat Abhiyan in the college has always been at the forefront. At this time, our students have been enthusiastically doing the work of cleaning the village by going around the village. For that, they do not need any strict rules or coercion, and this is the uniqueness of our initiative. Students voluntarily participate in this activity and work on how to conserve the environment. As a part

of environment conservation another different activity is done in our college and that is the student whose birthday is to plant a tree on that day. This innovative activity which is continuously going on in the college has not stopped even today. And the reason behind that is environmental conservation rooted in their minds. Since the children who work in the agricultural soil are our students, their intimacy with nature was already strong.

Our Mahavidyalaya has provided them a unique and desired platform for that. Our Mahavidyalaya is known as environment friendly.
